#### **Chief's Report:**

- 1. AED pads are needed
- 2. Cash flow in budget is being looked at for over the next few years
- 3. Registered on SourceWell site regarding paving. This is to find out what is covered by state and federal contracts.
- 4. Engine committee bid packages have gone out to about 10 companies. Notice has also been posted to our website and Town of Union website. The Board decided not to place notice in the newspaper. Two companies have declined to bid.
- 5. Have not received a date on starting the driveway patching

- 7. Many projects being looked at: shipping container, training building roof, AED's, LED lights on Chief vehicles

1. Aratura will be reached out to tomorrow regarding his bid for snow removal as Schroedel doesn't believe he fully understood the quote request. The quote was:

2. Still waiting to hear from Maine Fire on purchase of the old Blitz Fire.

### **New Business:**

- 1. Dumpster was totally filled by a resident. Question was asked if we should we lock it again as it happens every once in a while. Apparently, the address was identifiable, and the landlord will be called.
- 2. Motion made by Steinhiser, second by Schroedel to deem the old Blitz Fire as surplus equipment, with selling price to be determined at a later date. All Commissioners voted and the motion passed unanimously.
- 3. Motion made by Steinhiser, second by Schroedel to allow the Fire Police to hold a meeting at Station1 on October 24 at 11:30 3 pm. All Commissioners voted in favor and the motion passed unanimously.
- 4. Motion was made by Schroedel, second by Loveland to adopt the proposed budget for 2021. All Commissioners voted in favor and the motion passed unanimously.
- 5. Motion was made by Schroedel, second by Steinhiser to prepay Gauch Distributing for the purchase of a gear washer extractor at a cost of \$9,942. Cost will come from Building and Grounds Improvements. All Commissioners voted in favor and the motion passed unanimously.
- 6. Motion made by Schroedel, second by Loveland to hold the budget hearing on October 20 at 6 pm. All Commissioners voted in favor and the motion passed unanimously.
- 7. Motion was made by Steinhiser, second by Loveland to do pavement patching at Station 1 not to exceed \$6,000. Town of Union will do this patching. All Commissioners voted in favor and the motion passed unanimously.
- 8. Training building roofing was discussed. Motion made by Loveland, second by Heide by Penn-York Construction at a cost of \$4,315.00 with money to come from Building & Grounds Improvements. Roll call vote: Heide yes, Loveland yes, Steinhiser no (for safety & regulatory issues), Schroedel abstain. Motion did not pass due to not having a quorum of affirmative votes.
- 9. Town of Union will be contacted regarding putting a shipping container on our property. Motion made by Schroedel, second by Steinhiser to authorize the Chief to purchase a shipping container for water training not to exceed \$3,000, pending permission by Town of Union. Money to come from Building & Grounds Improvements. All Commissioners voted in favor and the motion passed unanimously.
- 10. Purchase of AED's will be held over until next month.
- 11. Establishment of a repair reserve fund will be held over until next month. This will have to be on the ballot in December if we decided to create the fund.
- 12. It is desired to purchase a new projector and computer and whatever else may be needed to upgrade the audio-visual system in the training room. Motion made by Schroedel, second by Loveland to purchase a projector, computer & monitor at a cost

- not to exceed \$5,000. Money will come from department computer budget line. All Commissioners voted in favor and the motion passed unanimously.
- 13. Motion made by Steinhiser, second by Loveland to upgrade lighting on the training building, not to exceed \$1000. All Commissioners voted in favor and the motion passed unanimously.
- 14. Motion Schroedel, second by Loveland to allow an upgrade to the LED's on the Chief's vehicles at cost not to exceed \$1,800, money coming out of the new equipment budget line. Roll call vote: Heide yes, Loveland yes, Steinhiser no, Schroedel yes. Motion passed.
- 15. Gear washing policy is not being followed. It is being worked on by the Chief's.
- 16. Gas meter calibrations are not being done every month
- 17. Engine 1 backup lights and sound is becoming very soft. This rig just passed inspection, but it will be looked at.
