#### Chief's Report:

- 1. There was a lengthy discussion on the new engine time line and the Commissioners are ok with it. However, we must keep watch of tax revenues, etc as purchase on this time line will seriously deplete the reserve accounts.
- 2. OSHA is not completed by several members. Those not completing should lose access to everything except station 1 until all training is completed.
- 3. No training classes are being held by county
- 4. May 5<sup>th</sup> we may resume and do mostly outside training
- 5. Arrow trailer is now running
- 6. Discussion was held on upgrading/replacing the current gear washer to a more modern washer to improve decontamination of gear following a fire. Will be discussed in a work session.

The sexual harassment policy needs updating regarding how/who to report any incident to. The insurance company will be reached out to checking to see if they have a letter regarding this, so the policy can be updated.

#### **Old Business:**

#### **New Business:**

- 1. Everyone needs to follow policies regarding the procedures for COVID. Bills had questions on them and concerns were supposed to be sent out to commissioners so all were aware. This caused scrambling to get answers at the last minute.
- 2. Questioned people using the station for non-essential business. All non-essential / non-emergency meeting needs to be stopped immediately.

  Motion made by Steinhiser, second by Griffith:

To be consistent with other local fire departments in the area, and to remain in compliance with the direction set forth by Governor Cuomo and the Broome County Executive Jason Gardner. The Board of Fire Commissioners have voted to restrict access to both stations including temporarily closing the exercise area at station 2. Access to the stations are for emergency response only (eg: dispatched by county) or while performing one of the activities listed below. These restrictions will remain in place until such time as deemed appropriate by the Board of Fire Commissioners. Members in violation will have their actions reviewed by the Board of Fire Commissioners and face disciplinary action.

If any further guidance is needed please reach out to the Board with your questions for clarification prior to accessing the station or grounds.

#### The following list is the only exemptions to the above-mentioned restrictions:

- Emergency Response
- Repairs deemed appropriate & necessary by the chief and approved by the Board of Fire Commissioners
- Monthly & weekly rig checks (to be completed individually using social distancing and appropriate PPE)
- Official Business of the Fire District by District Officers
- Fire Company Officer to retrieve mail for bill payment
- District meetings and work sessions (utilizing "zoom" meeting and social distancing)
- Food distribution as previously approved

All Commissioners voted in favor and the motion passed unanimously.
